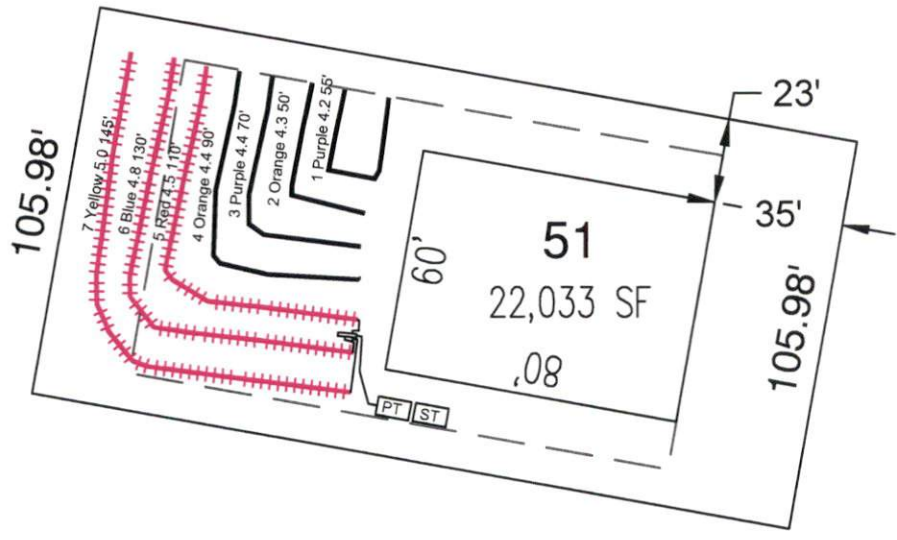

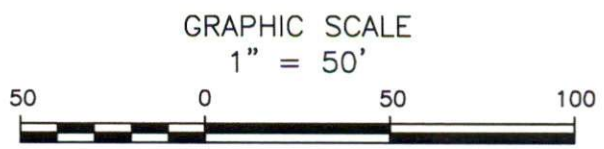
SITE SKETCH
