

ECS arrived on site, as requested, to check the bearing capacity of soils via hand auger/DCP method

(ASTM STP-399) for stem wall backfill. Please see the attached sketch and data sheet for details.

A total of 3 hand auger/DCP evaluations were performed to a depth of approximately 3 feet below the current backfill sub grade elevation. Test results indicated that the materials in place (at the locations and elevations tested) did appear to be suitable to support the design bearing capacity of 2,000 psf.
