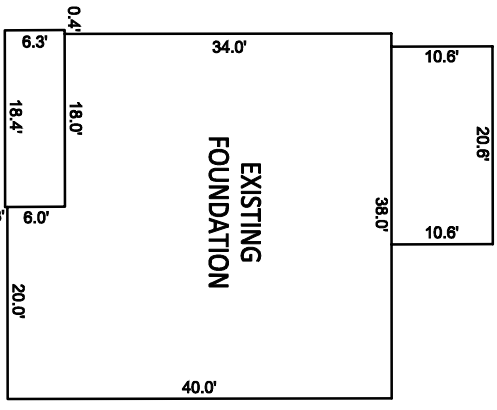

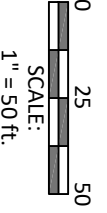
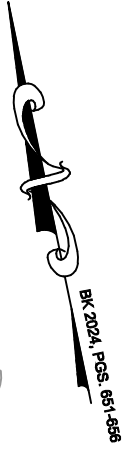


BUILDING SETBACKS

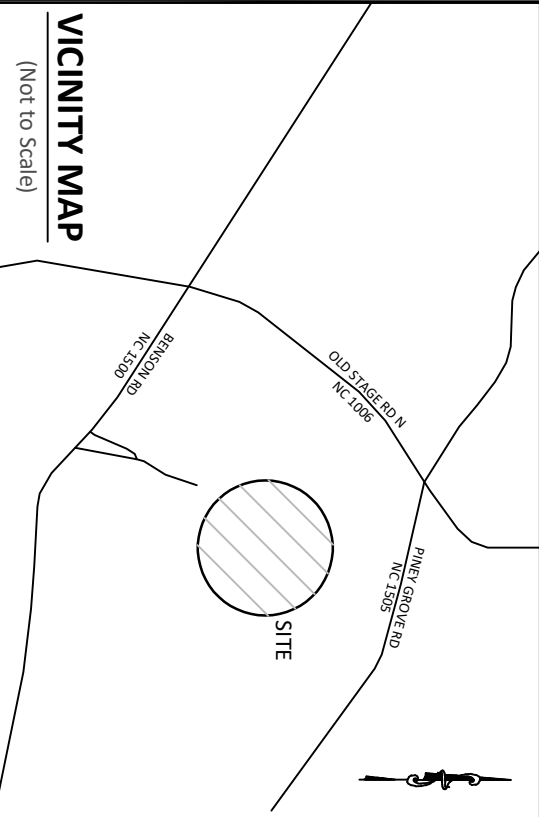

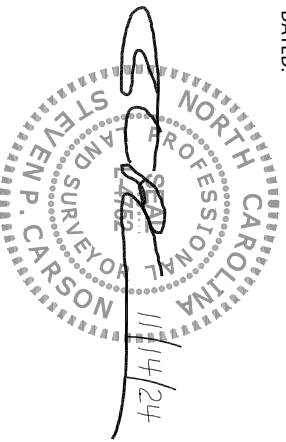
