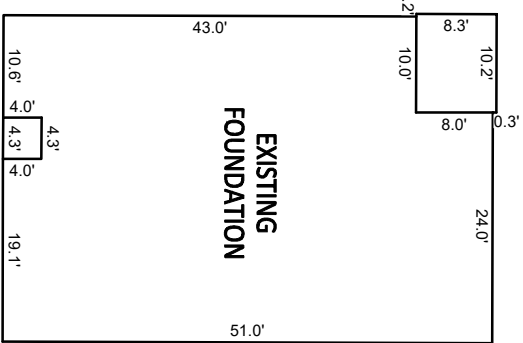

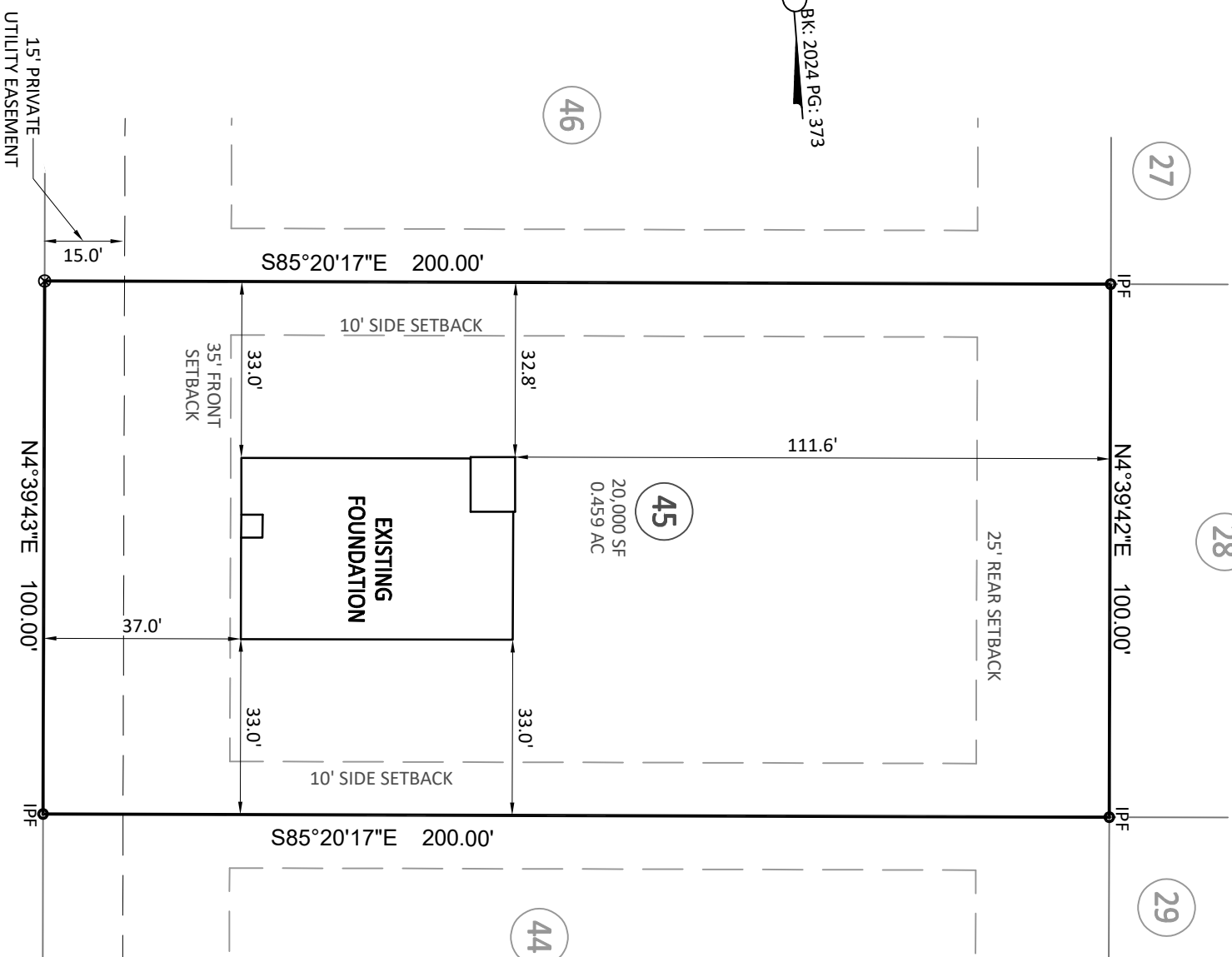

 CORNER SIDE - 20'



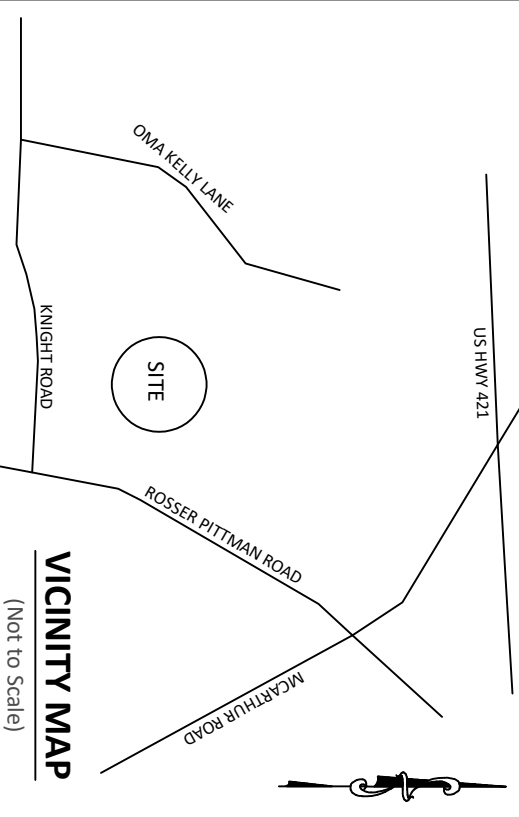

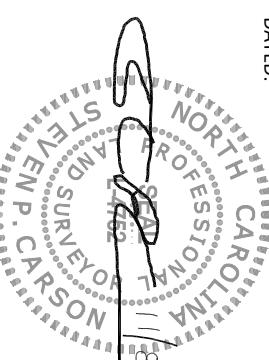
**VICINITY MAP**
