NORTH CAROLINA GENERAL WARRANTY DEED  
(NO TITLE SEARCH--NO TAX ADVICE)

THIS DEED made this 19<sup>th</sup> day of September, 2016, by and between CURRIN AND DORMAN, INCORPORATED, 156 S. McKinley Street, Coats, North Carolina 27521, Grantor, and DENISE CURRIN MATTHEWS, 156 S. McKinley Street, Coats, North Carolina 27521, Grantee;

The designation Grantor and Grantee as used herein shall include said parties, their heirs, successors, and assigns, and shall include singular, plural, masculine, feminine or neuter as required by context.

WITNESSETH:
