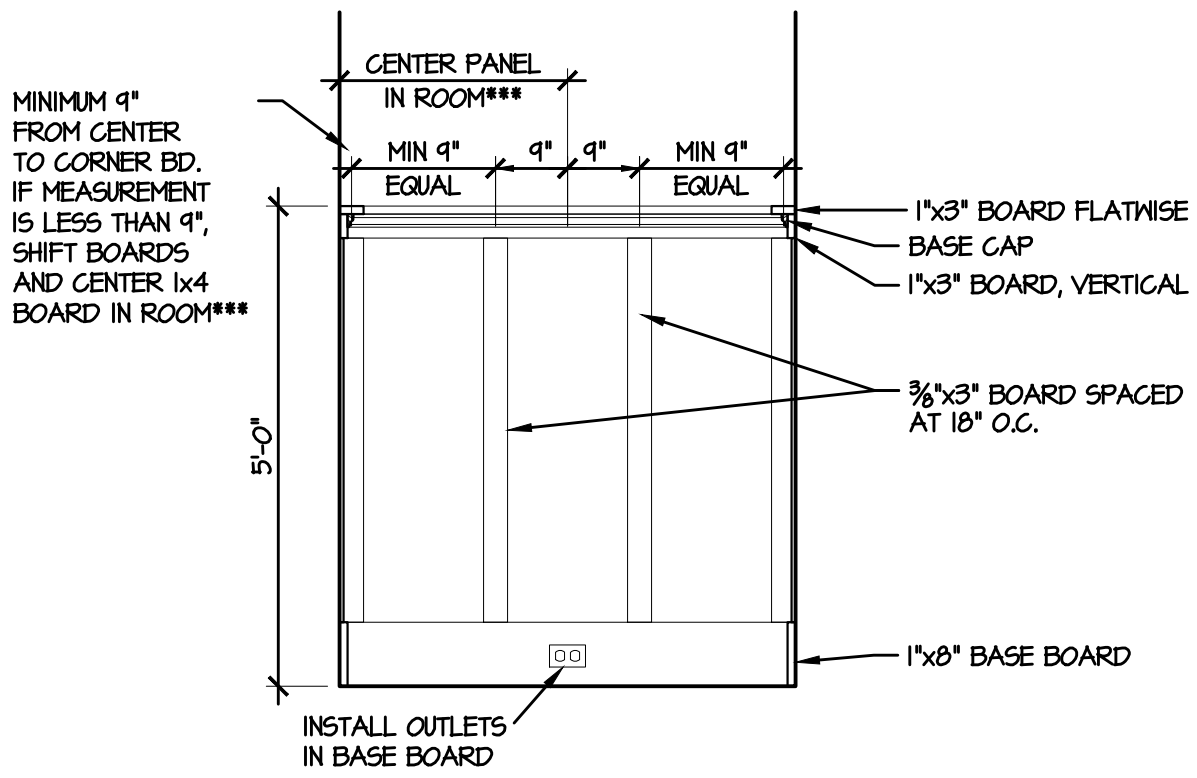
C STAIR CROSS SECTION
