#### Mr. Appel:

At your request, a site visit was made to the above referenced single family residence under construction to inspect footing projection concerns noted by the county inspector.

#### Observations:

Several 16"x16" CMU piers were not located within the center one-third of the footings and have projection exceeding the thickness of the footings on at least one side. However, all pier footings were verified to have a minimum 2" projection at all sides.

### **Analysis and Recommendations:**

Analysis based on the soil bearing capacity, pier footing sizes, and resultant forces imposed by the piers onto their footings revealed the "as-built" pier and footing configurations are adequate. No footing or foundation modifications are required.
