Maximum gusset spacing to be the lesser of 36" o.c. or the maximum Top Chord purlin spacing as shown on the individual Engineering Truss Drawings.

IMPORTANT

This repair to be used only with trusses (spans less than 40') spaced 24" o.c. maximum and having pitches between 5/12 and 10/12 and total top chord loads less than 50 psf.

Trusses not fitting these criteria should be examined individually.

ATTACH 2x_ SCAB OF THE SAME SIZE AND GRADE AS THE BROKEN MEMBER TO EACH FACE OF THE TRUSS (CENTER ON BREAK OR SPLICE) WITH 10d (0.131" X 3") NAILS (TWO ROWS FOR 2x4, THREE ROWS FOR 2x6) SPACED 4" O.C. AS SHOWN. STAGGER NAIL SPACING FROM FRONT FACE AND BACK FACE FOR A NET 0-2-0 O.C. SPACING IN THE MAIN MEMBER. USE A MIN. 0-3-0 MEMBER END DISTANCE.

THE LENGTH OF THE BREAK (C) SHALL NOT EXCEED 12". (C=PLATE LENGTH FOR SPLICE REPAIRS)
THE MINIMUM OVERALL SCAB LENGTH REQUIRED (L) IS CALCULATED AS FOLLOWS:


Symbols

PLATE LOCATION AND ORIENTATION

Center plate on joint unless X, Y offsets are indicated.

Dimensions are in ft-in-sixteenths.

Apply plates to both sides of truss and fully embed teeth.



For 4 x 2 orientation, locate plates 0-1/16" from outside edge of truss.



This symbol indicates the required direction of slots in connector plates.



PLATE SIZE

4 x 4


The first dimension is the plate width measured perpendicular to slots. Second dimension is the length parallel to slots.

LATERAL BRACING LOCATION



Indicated by symbol shown and/or by text in the bracing section or the output. Use T or I bracing if indicated.

BEARING



Indicates location where bearings (supports) occur. Icons vary but reaction section indicates joint number/letter where bearings occur. Min size shown is for crushing only.



Trusses are designed for wind loads in the plane of the truss unless otherwise shown.

Lumber design values are in accordance with ANSI/TP1 section 6.3. These truss designs rely on lumber values established by others.

General Safety Notes

Failure to Follow Could Cause Property Damage or Personal Injury

1. Additional stability bracing for truss system, e.g. diagonal or X-bracing, is always required. See BCSI.

2. Truss bracing must be designed by an engineer. For wide truss spacing, individual lateral braces themselves may require bracing, individual lateral braces themselves may require bracing, or alternative Tor! bracing should be considered.

3. Never exceed the design loading shown and never stack materials on inadequately braced trusses.

4. Provide copies of this truss design to the building designer, erection supervisor, property owner and all other interested parties.

5. Cut members to bear tightly against each other.

6. Place plates on each face of truss at each joint and embed fully. Knots and wane at joint locations are regulated by ANSI/TP1.

7. Design assumes trusses will be suitably protected from the environment in accord with ANSI/TP1.

8. Unless otherwise noted, moisture content of lumber shall not exceed 19% at time of fabrication.

9. Unless expressly noted, this design is not applicable for use with fire retardant, preservative treated, or green lumber.

10. Camber is a non-structural consideration and is the responsibility of truss fabricator. General practice is to camber for dead load deflection.

11. Plate type, size, orientation and location dimensions indicated are minimum plating requirements.

12. Lumber used shall be of the species and size, and in all respects, equal to or better than that specified.

13. Top chords must be sheathed or purlins provided at spacing indicated on design.

14. Bottom chords require lateral bracing at 10 ft. spacing, or less, if no ceiling is installed, unless otherwise noted.

15. Connections not shown are the responsibility of others.

16. Do not cut or alter truss member or plate without prior approval of an engineer.

17. Install and load vertically unless indicated otherwise.

18. Use of green or treated lumber may pose unacceptable environmental, health or performance risks. Consult with project engineer before use.

19. Review all portions of this design (front, back, words and pictures) before use. Reviewing pictures alone is not sufficient.

20. Design assumes manufacture in accordance with ANSI/TP1 Quality Criteria.

21. The design does not take into account any dynamic or other loads other than those expressly stated.
