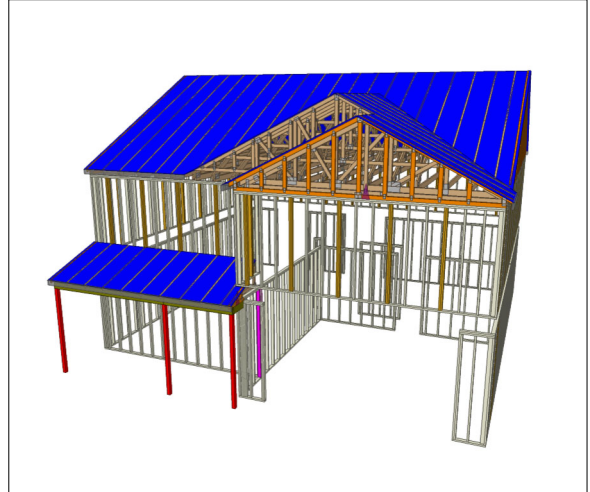

8. Components must be handled and installed following all applicable safety standards and best practices, including but not limited to BCSI, OSHA, TPI and local codes. Failure to properly handle, brace or otherwise install Component can result in serious injury or death.
9. All uplift connectors shown within these documents are recommendations only. Per ANSI/TPI 1, all uplift connectors are the responsibility of the building designer and or contractor.

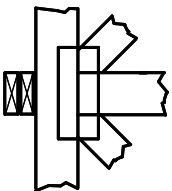

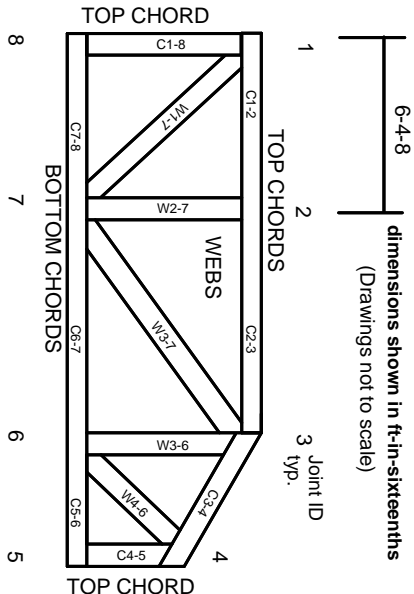
