No. I have not heard any response from anyone from Overhills Middle School. Below is a brief description of the situation.

Based on my best available information (looking on google maps and streetview, I have not been out to the site) there appears to be two existing ground signs already on this parcel. Under the Harnett County UDO technically there is only a maximum of one (1) allowable ground sign for this site. But in speaking with the other staff there are a few options:

- 1. Upgrade one of the existing signs by adding the digital reader board portion to an existing sign will be fine. The "upfit" will still have to meet all other size requirements (total sq. footage and percentage of allowable digital reader board). Or,
- 2. Remove the concrete sign (pictured below) near the existing entrance and replace with the proposed sign (in the currently proposed location).
