He has had it done like that for over 6 months and also runs his electricity from his dad's water pump house, and uses a water hose ran about 50 yards from the pump house for bathing and to be able to flush the toilet. It backs up into the camper at least once a week, and it has a gas like smell that has caused me major health problems. His father rents the property that's only deemed to have 1 residential homes on the property but has 2 percent campers and a house that's very unfit to live in. It's environmentally unsafe living conditions and he didn't have any kind of permit for doing any of the septic work and or any for building anything he's built
