Seemingly I was told that there was a grant that allowed for the removal of these type homes in our county. We need your help!! Are these provisions still available?

I will seek other options but at this point I am sure that it won't be prior to May 30, 2025. Even if I can get a church organization to assist they won't be able to make this happen I am sure not within the next month. There is no need to fine me \$100.00 and then \$100 a day and cause a financial hardship for my family in the current economic environment with all of us not so sure that we will have employment from day to day or afford the cost of meals. I am requesting mercy acknowledging that I am aware of the violation and am attempting to remedy the situation. There are a great deal of violations in Harnett County and it is noted just by driving down the street therefore this indicates that this is indeed a need of the taxpayers in Harnett County. Again, we need the county's

support. Is there an upcoming county hearing that I can present that evening to request this type support.

In closing, Randy, if there is indeed an organization wiling to assist our family in the removal of this dwelling please forward this information to me. I can be reached at jelidan2012@yahoo.com or by mail. I need your help. You are an important member of the community in addition to your role with the Harnett County Development Services therefore I am sure that the members of this community are valuable to you. I have paid so much money to have items hauled from that property. Each time we go out there it seems that someone has used the area as a dumping ground. Costs have been astronomical to the point that they throw things on the property which makes it difficult for us to even upkeep the grounds. Our plan is to remove the structure and then place a nice fence around it. Again, once we have the structure removed in the near future a family member will purchase a mobile home and establish it on that lot but my father will not return there unfortunately.
